The Honourable John Baird


Former Minister of Foreign Affairs and Senior Advisor at Eurasia Group



Vicki Saunders


Serial Entrepreneur and Founder of the Global Movement, SheEO

Vicki has co-founded and runs ventures in Europe, Toronto, and Silicon Valley, including Zazengo (an online platform for consumer and employee engagement for Fortune500 companies focused on sustainability); KidsNRG/The NRG Group; and Impactation, a global consulting firm focused on engaging youth to tackle the grand challenges we are facing.



### PEACE BY CHOCOLATE


Tareq Hadhad

In 2012, Tareq Hadhad's family home and chocolate factory in Syria were destroyed by war, forcing them to seek safety in other countries. A former medical student at Damascus University, Tareq joined medial relief efforts before being welcomed to Canada on a community-based sponsorship in December 2015.


After arriving in Canada, Tareq and his family relaunched the family business to recreate the chocolates they once exported across the Middle East. Today, they manufacture 100,000 pieces of chocolate a month and have plans to triple the production in their new factory. Tareq and his family are now focused on job creation, utilizing a network of Syrian refugees from across Nova Scotia with the plan to expand across Canada, offering other newcomers job opportunities.

Tareq will share his family's compelling story and his passion for peace. He will also touch on the spirit of entrepreneurship and the qualities that allowed his family to show deep resiliency in the face of extraordinary challenges and change.





### **RESILIENCY: THE MEDICALIZATION OF UNHAPPINESS**

The impact of Mental Health issues on society and employer benefit costs continues to increase. It is apparent that normal, expected bouts of sadness have become “medicalized”, and we are medicating large portions of the population across the varying age bands.

Are there other strategies for care that would better help these patients? Where do therapy and wellness professionals fit in? What are the options available and what are the statistics that support these options?

This session will examine the history of mental illness in Canada, how it has been treated (and/or gone untreated) and explore the consequences of the practices that have prevailed. We will review how much the landscape has changed over the last few decades and will zero in on the changing medical and social landscape that has led to the proliferation of mental health diagnoses and the widespread prescribing of anti-depressants. 
### **INSIGHTS ON BLOCKCHAIN AND CRYPTOCURRENCY**


Innovative technologies have transformed the way that we perform daily business operations, and Fintech continues to evolve with Blockchain and cryptocurrencies gaining traction.


### **ETF's IN RETIREMENT PLANS**



This begs a few questions: Are these valid worries for this asset class, and are ETF's appropriate for both Defined Benefit and Defined Contribution plans?

Join us as Cam covers the ETF Landscape and provides a general overview of ETF products, the growth of this asset class, and emerging trends. He will also delve into the pros and cons for both DB and DC pension plans utilizing ETF's.

Dave Wowchuk will provide commentary on plan design strategies to limit private plan exposure and drive coordination with public/drug manufacturer programs. Kenneth MacDermid will provide a plan sponsor perspective on optimizing funding arrangements/pooling and drug plan modernization strategies to optimize plan performance.

## Session 6

### **REPLACING THE REPLACEMENT RATE: HOW MUCH IS “ENOUGH” RETIREMENT INCOME?**


Bonnie-Jeanne MacDonald, Senior Research Fellow of the National Institute on Ageing (NIA), Ryerson University and Resident Scholar at Eckler Ltd.

For years, the standard for measuring retirement income adequacy has been the final earnings replacement rate (usually targeted at 70%). Financial planners, actuaries, pension plan advisors, academics and public policy analysts all use this benchmark. It's the measure that underlies our pension systems, drives the research that determines whether populations are prepared (or not) for retirement and serves as the backbone of retirement planning software. But the question is, does it work? Will 70% of a worker's final annual employment earnings actually sustain his or her living standards after retirement?


Bonnie-Jeanne will examine whether workers who hit this target, can expect to maintain their living standards in retirement, and will also discuss an alternative, more accurate, basis for assessing how well a worker's living standards are maintained after retirement - the Living Standards Replacement Rate.

Based on ten years of research and analysis, this award-winning work has been receiving media attention and is now being used in the “real world” financial retirement service industry “how much is ENOUGH retirement income?”

### **DIVERSITY IN THE WORKPLACE: CONSIDERATIONS FOR DESIGNING INCLUSIVE BENEFITS**


### Bastringue – Late Night Reception

### Winery Tour – Casa Nova Fine Beverages, Bear River




### Nova Scotia Tasting Bar at Late Night Reception





Take Highway #102 toward Halifax. Take Exit 4 (Annapolis Valley - Highway #101). When you reach Digby, take Exit 26 and follow the signs for the ferry to Saint John. The resort is 3km before the ferry terminal, located at 103 Shore Drive. Travel time is 2.5 hours.

#### **From Halifax, NS – By Car**

Take Highway #102 from Halifax. Take Exit 4 (Annapolis Valley - Highway #101). When you reach Digby, take Exit 26 and follow the signs for the ferry to Saint John. The resort is 3km before the ferry terminal. Travel time is 2.5 hours.
