Thursday Morning Keynote **David Frum**

2025 and Beyond - Trump and Canada

Pierre Trudeau famously described Canada's relationship with the US as "sleeping with an elephant". With each unpredictable shift and turn, Canada is waking up to the risks from our increasingly precarious bed partner.

The return of Donald Trump to the presidency challenges Canadian trade and security. Dr. Yoni Freedhoff

Weighing In on Obesity Treatments

In 1997 the World Health organization declared obesity a disease and an official epidemic, and since this time, the rates of obesity have nearly doubled. With equity and inclusiveness coming into focus for plans and new treatment options emerging, this category of drugs, which were formerly referred to as "lifestyle", are getting renewed focus. But at what cost? And how is social media playing a role in shaping our perceptions? Join us for a frank discussion with one of Canada's leading voices in this field, Dr. Yoni Freedhoff.

The questions for plan sponsors abound: What are the coverage criteria and how can plans balance access and affordability? What should human resource professionals consider when weighing options, from labour relations to attraction and retention risks? What will new generic options in the therapy category mean for plan costs? Are there longer-term implications/outcomes to consider for pension and benefit plans with respect to mortality and morbidity?

Dr. Yoni Freedhoff will explore the ten most common arguments against the use of these drugs; contrast outcomes with lifestyle interventions and other treatment options; discuss the seeming contradiction that despite improved outcomes, many people stop using these drugs within a year; and considerations for balancing access with plan affordability. With a thirty-minute presentation and fireside chat to follow, this is a must see session for conference attendees across all industries.

Speaker Bio: Associate Professor of Family Medicine at the University of Ottawa and the medical director of both Ottawa's Bariatric Medical Institute, and the coast-to-coast RD delivered program and app Constant Health. Widely regarding as Canada's most outspoken expert in obesity, testifying in front of both the House of Commons and the Senate and a fixture on both National and International media regarding nutrition, public policy, and obesity.





Mental Health and Psychological Safety

Speakers: Dr. Robert Tanguay, University of Calgary, Canadian Addictions Council

Alex Boucher, Mercer

The data is clear! People are struggling with mental health conditions, like never before, and the related costs are skyrocketing.

- 2-in-5 Canadians live with a mental health disorder, and 1-in-2 will have had or are currently living with a mental health disorder.
- 500,000 Canadians miss work every week due to mental health concerns.
- Approximately 8 million Canadians suffer from addiction and 10 Canadians die in hospital every day from substance use, where 75% of that is related to alcohol use.
- Significant wait lists for many specialists, which delays treatment, recovery, and returning to the workplace.

This session will delve into strategies for achieving mental wellness for individuals facing mood disorders, PTSD, trauma, anxiety, depression, and addiction. We will discuss the use of evidence-based assessments, medications, and therapeutic approaches that promote healthy work environments and facilitate recovery. Furthermore, we will examine the critical role of the workplace in preventing and minimizing psychological harm, highlighting the unique opportunity employers must foster healthy work practices, support healthy lifestyles, and enhance both recovery and productivity.

Session 2 (Pension/Investments)

The Decumulation Dilemma

Speaker: Michael Carter, Sun Life

The rise of capital accumulation plans in Canada, along with an aging population, has increased plan sponsor focus on retirement spending. Helping plan members manage through their decumulation years is arguably a more challenging problem than plan design in the accumulation years. This dilemma is rooted in the inherent trade-offs with decumulation goals, as well as in the sequence of return risk and limited alternative investment options for CAP members. However, there are ways that plan sponsors can better deal with this decumulation conundrum.








Getting Here



Prince Edward Island, Canada's smallest province, is nestled in the Gulf of St. Lawrence between the provinces of New Brunswick, Nova Scotia, Québec, and Newfoundland and Labrador. It is accessible by air as well as by ferry and the 13-km Conferderation Bridge.





Confederation Bridge

The Confederation Bridge is a 13-km engineering phenomenon. Connecting from New Brunswick, the Bridge is open 24 hours a day and takes approximately 12 minutes to cross. Tolls are collected when leaving PEI.



Northumberland Ferries Limited

Northumberland Ferries departs from Caribou, Nova Scotia to Wood Islands, Prince Edward Island on a regular schedule. The trip takes 75 minutes and fare for the ferry is paid when leaving the Island.
